Important Notes at the Challenging Times of COVID-19 Pandemic

The global COVID-19 pandemic has had a significant impact on all social and sporting activities with movement and travel restrictions imposed by governments across Europe. These restrictions are gradually relaxed in some part of the world, making it is possible to organise sporting competitions again under updated conditions and protocols.

The health and safety of players, coaches, officials and fans remain the CEV's top priority and to achieve this goal, a number of documents have been developed including the CEV Competitions Hygiene Guidelines <https://inside.cev.eu/media/ggaka0aa/cev-competitions-hygiene-guidelines.pdf>.

For the EuroBeachVolley 2020 in Jurmala (LAT) the following measures will be applied **for All Delegation Members (athletes, coaches, scouts, physios/doctors) officially accredited within the set deadlines** to ensure entrance to the country and participation to the competition:

1. A printed COVID-19 NEGATIVE TEST CERTIFICATE (in 2 copies) which must be carried out not later than 3 days (72 hours) prior to arrival. The test needs to be conducted by an accredited/certified laboratory
2. A duly completed and signed STATEMENT form submitted through the respective National Federation to the Local Organising Committee-LOC (sandra.selga@volejbols.lv) **by 7 of September 2020 the latest**. The form confirms that all delegation members will follow the National Authorities requirements as specified in regulation Paragraph 61. 4. (see here - <https://likumi.lv/ta/en/en/id/315304-epidemiological-safety-measures-for-the-containment-of-the-spread-of-covid-19-infection>)
3. A signed copy of the CEV WAIVER annexed to this Practical Info
4. A detailed travel schedule BV-04 form to be submitted to the LOC (sandra.selga@volejbols.lv) **by 7 of September 2020 the latest**.

Travel Restrictions (constantly updated):

The Latvian government allows a list of nationalities to enter the country without any restrictions but there is a list of countries/nationalities which are marked in red or yellow that are obliged to fulfil special rules and follow procedures as stated in Latvian legislation.

This list is updated weekly (last expected update prior to the tournament is on 11 September 2020) and can be viewed on the website of the Latvian Centre for Disease Prevention and Control <https://www.spkc.gov.lv/lv/valstu-saslimstibas-raditaji-ar-covid-19-0>. Countries not listed in the respective list are considered as red.

For all Delegations members entering Latvia from countries without restrictions and who have not been in a yellow or red country up to 14 days prior to arrival no special arrangements are imposed upon arrival and they will be handling the above mentioned documents to the LOC upon arrival / during the Preliminary Inquiry.

For all Delegations members entering Latvia from countries within the yellow/red countries list or who have been in a yellow or red country up to 14 days prior to arrival the following provisions occur:

- Need to arrive in Latvia the latest by 12:00 noon should they decide to arrive on the day of the Preliminary Inquiry
- Undergo a PCR test upon arrival at the airport. The result of the test will become available within maximum 8 hours and the persons concerned will need to self-isolate in their room waiting for the result

- Handle to the LOC staff at the airport the negative COVID-19 test and the STATEMENT form. By handing over the above documents each person agrees to respect and fulfil the following conditions as mentioned in the STATEMENT form:
 - i. will stay in the place of residence indicated in the STATEMENT FORM throughout their staying in the territory of the Republic of Latvia apart from participation in the international sports event "CEV EuroBeachVolley 2020, Jurmala, Majori beach, LATVIA";
 - ii. will collaborate during their stay in the territory of the Republic of Latvia with the CEV and the LOC in monitoring their health condition (twice a day - morning and evening - by measuring body temperature) and inform the responsible event person i.e. Hygiene Officer and CEV Medical Delegate if any signs of acute respiratory infectious disease appear (cough, fever, shortness of breath);
 - iii. will not use public transport to get to the place of residence in the territory of the Republic of Latvia and the venue of the international sports event in the territory of the Republic of Latvia;
 - iv. will cover all medical & accommodation expenses if diagnosed with Covid-19 infection.

On compliance with the non-application of self-isolation requirements for foreigners during the performance of work duties

We, undersigned, based on LR Cabinet Regulation No. 360 "Epidemiological Safety Measures for the Containment of the Spread of COVID-19 Infection", adopted on 9 June 2020 (hereinafter – CR No.360) paragraph 60, * < Name of National Federation represented by Name of representative > hereby certify that:

- will cover all medical expenses if a foreigner is confirmed to have a Covid-19 infection;
- the persons indicated in the Statement attached Appendix No.1 have been informed that their personal data (i.e. name, surname, personal identification code, occupational classification (if applicable)) will be transferred to the Latvian Investment and Development Agency by submitting a statement of compliance with the non-application of self-isolation requirements for foreigners, and, in case of necessity, also to other institutions for performance of Covid-19 infection control measures in accordance with the procedures specified in regulatory enactments
- Is informed and undertakes to monitor that foreigners comply with all restrictions set in the country, as well as take responsibility for non-compliance with restrictions

EuroBeachVolley 2020, Jurmala – Waiver document

Given the current COVID-19 Pandemic and the efforts made by the CEV and the Local Organizer, important information is included in the Practical Info document for the EuroBeachVolley 2020 in Jurmala, Latvia regarding the National and local regulations in place during the period of the event.

Additionally, the CEV has reviewed its protocols with its internal experts, including its Medical Commission, so that they can be adjusted to the current concerns facing all of us as a result of the pandemic. Further information is also available on the CEV's website <https://inside.cev.eu/en/covid19> with dedicated information and resources regarding the pandemic:

The CEV wants to ensure that all of its stakeholders have all of the necessary information related to COVID-19 and has taken steps to minimize the potential risk of COVID-19. However, the CEV notes that a risk of COVID-19 still exists despite all efforts.

With the information provided in the EuroBeachVolley Practical Info document, the CEV's and the National Authorities websites, we would like to inform you of the possible risks involved in this CEV competition, that includes the travel to and from the event and that you are participating in your own free will and that you are aware of and assume the possible risks related to the COVID-19 by participating in this event.

To be specific, by acknowledging this document and continuing to participate in the event after receiving it as part of the Practical Info document, you are aware and agree that:

1. While the local protocols and personal discipline may reduce this risk, the risk still does exist; accordingly, your participation includes possible exposure to and illness from infectious diseases, including but not limited to COVID-19; and,
